THE WIDE RANGE OF EXHIBITIONS REFLECTS THE ENCYCLOPEDIA NATURE OF THE MUSEUMS, AND INCLUDED: UNCANNY VALLEY: BEING HUMAN IN THE AGE OF AI; FRIDA KAHLO: APPEARANCES CAN BE DECEIVING; DE YOUNG OPEN FEATURING UPCOMING BAY AREA ARTISTS; CALDER-PICASSO; LAST SUPPER IN POMPEII FROM THE TABLE TO THE GRAVE & WANGECHI MUTU: I'M SPEAKING ARE YOU LISTENING? THE MUSEUMS WELCOMED 303,000 GUESTS IN FISCAL 2021, WHICH WAS LOWER THAN THE PRIOR YEAR DUE TO EXTENDED COVID CLOSURES AND RELATED STATUTORY LIMITS ON ATTENDANCE DUE TO CITY REQUIREMENTS.
